ORDER

As per reference read as 2nd and 3rd paper above, Government constituted a committee to identify the various problems faced by schools of Mentally Retarded Children and to offer remedial recommendation. As directed, the committee submitted the study report with specific recommendation to Government. One of the recommendations was to convert some of recognized Mentally Retarded Schools into aided status on par with the student strength. As per reference read as 4th paper above Government have brought the Administrative control of the schools for Mentally Retarded from Social Welfare Department, to the Public Instruction and General Education Department.

Government have examined the recommendation of the committee in detail and are pleased to appoint. Joint Director of Public Instruction (Academic) as completed authority to issue certificate of Registration in respect of Mentally Retarded Schools in the state hereafter, subject to the conditions and guidelines issued as per the reference read as 1st paper above.
