ORDER

1. As per the Government Order read as first paper, Government have approved the Kudumbashree Project which aims at eradicating poverty both in Urban and Rural areas of the State through women empowerment. In the Government order read as first paper it was 'interalia' ordered that UPA Cell would be merged with State Poverty Eradication Mission (SPEM) as and when it comes to existence. For implementation of the project the SPEM has been constituted as per Government Order read as second paper above. It was also ordered in this Government Order that the Executive Director, SPEM will takes steps to wind up the State UPA Cell and to transfer all its assets and liabilities to the mission. In compliance with the above orders, the Executive Director had transferred the assets, liabilities and Staff of the UPA Cell to SPEM with effect from 31.3.99. As per the letter read as third paper, the Executive Director, SPEM has requested to issue orders winding up of the UPA Cell and declaring the SPEM as State Urban Development Agency (SUDA) in the State for the implementation of Centrally Sponsored anti-poverty programmes for the Urban poor as provided for in the Memorandum of Association of SPEM.

2. In the circumstances explained above Government Order the winding up and merger of State UPA Cell with SPEM with effect from 31.3.99 and declare the SPEM as the State Urban Development Agency in the State for the implementation of Centrally sponsored anti-poverty programme for the Urban poor. The action of Executive Director, SPEM in transferring the assets and liabilities of the former State UPA Cell to the Mission in anticipation of formal sanction of the Government, it also ratified.

Consequent to the merging of State UPA Cell with SPEM all the activities and schemes undertaken by the UPA Cell will be continued by the SPEM.
